

# Microgrid filing authority



## Overview

---

The authorization process for microgrid operation involves obtaining necessary approvals from regulatory authorities before a microgrid can be officially energized and integrated into the existing grid infrastructure. Microgrid legal frameworks establish the foundational legal principles governing the development, operation, and integration of microgrids within the broader energy system. These frameworks vary significantly across different jurisdictions, reflecting local regulatory environments, policy . Authorized by Section 40101(d) of the Bipartisan Infrastructure Law (BIL), the Grid Resilience State and Tribal Formula Grants program is designed to strengthen and modernize America's power grid against wildfires, extreme weather, and other natural disasters that are exacerbated by the climate .
